## Dear Mayor Breed,

We, the undersigned, urge you to preserve the ongoing General Fund money that you allocated last year to fund seven SF Environment Department staff positions which are crucial to continue implementing the detailed and comprehensive Climate Action Plan you introduced in 2021. SFE's request of \$1.8 million in FY 2024-25 and \$1.6 million in FY 2025-26, a tiny fraction of the City budget, will keep these staff members working to bring in robust state and federal grant money, and to manage those funds most effectively to fight climate change. Missing such opportunities would cost the City dearly.

The growing climate emergency is a fundamental economic, public health, and livability threat that underlies and exacerbates many of the City's most urgent problems. As leader of San Francisco's climate response, you have provided strong support for adaptation and resilience strategies. On the mitigation side, you declared your ambition to achieve a net-zero emissions City by 2040 by enacting the CAP. We applaud your vision in committing last year to allocate ongoing budget funding to ensure that crucial staff would keep their jobs.

The small investment in these positions has already paid for itself as SFE has secured \$45.8 million in external funding since 2023. These staff positions are needed now to continue to increase the Department's ability to bring in federal, state and private funds - in a window of opportunity that may only extend for the next few years. This current budget request by SFE does not include new funding but is in accord with funds already in place with the promise of continuation each year.

A strong Environment Department can be the linchpin of the City's equitable transition to net-zero by 2040, with so many attendant benefits along the way. We ask that you fulfill your pledge to work towards achieving CAP goals by sustaining in the upcoming budget cycle the full Environment Department budget as promised for the next 2 years.

In the face of a severe budget deficit and worsening climate and pollution effects, San Francisco must pursue its most cost-effective path with vision. Climate change/pollution problems will cost so much more to solve if not addressed now. And as you know, low-income and BIPOC communities are always disproportionately affected as the planet warms. Please empower SF Environment to seize the current opportunity for San Francisco to persevere as a world-class city and a leader in climate action.
